

# **ACC 251 Managerial Accounting and Controls**

## **Course Description**

- This course will cover in-depth the cost and management accounting concepts that will enable you
  to make decisions, including interpreting business situations, identifying available options,
  interpreting their impacts on financial statements and stakeholders, and clearly and articulately
  recommending a course of action.
- As an essential part of the MPAc program, this course will prepare you effectively for relevant elements in the CPA exam, with integrated data analytics and visualization.
- More generally, this course will teach you real-world business insights/ethics/tools/skills that you will find helpful in your personal lives and careers.
- To achieve these objectives, this course examines the internal creation/use of accounting information in planning, controlling, and decision-making. In addition, it incorporates data analytics and visualization tools like Excel and Tableau.
