# **Course Description**

This capstone course in the financial reporting sequence integrates advanced topics essential for navigating the complexities of U.S. GAAP. You will explore critical areas such as the latest revenue recognition standard (ASC 606), accounting changes and error analysis, statement of cash flows preparation, financial instrument accounting, and consolidation of financial statements following business combinations. Beyond U.S. GAAP, this course also covers financial ratio analysis, risk assessment techniques, and emerging data analytics technologies, equipping you with essential analytical skills.

Mastering these topics will deepen your accounting expertise and provide comprehensive preparation for the Financial Accounting and Reporting (FAR) and Business Analysis and Reporting (BAR) sections of the CPA Exam.
